Subject: Response of the North & Western Lancashire Chamber of Commerce to Local Government Re-organisation.

I am writing on behalf of the members of the North & Western Lancashire Chamber of Commerce to express their collective response to the ongoing discussions regarding local government reorganisation in Lancashire.

We acknowledge that these decisions are ultimately political; however, we believe it is crucial to highlight the perspectives and preferences of the local business community, which plays a vital role in the economic vitality of the county.

Through significant consultation with our members, their conclusions strongly favour a three-unitary authority approach for Lancashire. Specifically, they support the following grouping:

- Preston, Chorley, West Lancashire, and South Ribble
- Blackpool, Fylde, Wyre, Lancaster
- East Lancashire

This structure aligns with natural economic footprints within the county and reflects the interconnectedness of these areas in terms of commerce, infrastructure, travel to work and community ties.

Furthermore, our members consider that establishing three unitary authorities would help reach the critical mass requested by the government, enabling more efficient governance, better resource allocation, and stronger economic development strategies. The above

structure will strengthen existing local identities and allows for coherent regional planning. It avoids the serious pitfalls of the two-unitary model, where one authority would be disproportionately large and the four-unitary model, where population sizes fall outside guidelines with transitional arrangements being highly disruptive. We also understand a model of five unitaries currently favoured by Burnley and Pendle is not under any circumstance a viable model for consideration.

We of course recognise that all options present challenges and trade-offs, including transition costs and service reconfiguration. However, a three unitary structure provides the most practical platform for businesses and communities to thrive.

Lancashire requires clarity, accountability and an efficient local government structure which strengthens our competitiveness. The Chamber considers a three-unitary model will deliver stronger local identity, provide more coherent strategic decision-making and a balance between efficiency savings and quality service.

The many options currently under discussion by local authorities (outside the three unitary model) do not adequately address concerns raised by the business community. Inclusion of the business community's position is vital to ensure that any restructuring benefits the entire community, promotes economic resilience, and supports sustainable growth.

We trust that the government will take into account these perspectives as part of the ongoing review process. We are keen to continue engaging with policymakers to ensure that Lancashire's local government structure best serves its economic future.
